

**MEMORANDUM OF UNDERSTANDING ACADEMIC, TECHNICAL AND SCIENTIFIC COOPERATION BETWEEN UNIVERSIDAD DISTRITAL FRANCISCO JOSÉ DE CALDAS (UDFJC – COLOMBIA AND LAND ECONOMICS MANAGEMENT CONSULTANTS & LEMCO INVESTMENTS LIMITED (LEMCO – UNITED KINGDOM)**

In order to promote cooperation between the Universidad Distrital Francisco José de Caldas -UDFJCI, Bogotá, Colombia and Land Economics Management Consultants & LEMCO Investments Limited – LEMCO, located in London, the parties agree to establish a Memorandum of Understanding to facilitate technical, academic and scientific cooperation, to develop joint efforts on academic exchange, scientific and technological transference, management of joint projects, investigative and applied projects and in any other way of cooperation that could result in mutual interest of the parties.

This Memorandum of Understanding is the support of strategic alliances between the parties, with the purpose of development of local, regional, national and international projects.



As a preparation for establishing a formal framework for future activities, the parties will:

- Advance training projects, technical assistance, research, outreach and development programs and innovation.
- Facilitate mobility of teachers, students and other personnel involved in the institutions in this cooperation agreement.
- Obtain external funding resources to develop research projects and outreach.

Themes of joint activities and the conditions for the use of the results achieved and arrangements for other forms of cooperation, such as studies and investigations, the supply of specialized products and services as the participation on assessments, technical assistance and the agreements for other cooperative joints will depend upon the availability of the resources and support of the institutions. Any binding commitments, financial or otherwise, for any activities developed under the auspices of this MEMORANDUM OF UNDERSTANDING will be made only in specific implementing agreements entered into for this purpose at a subsequent date.

This memorandum of understanding will be in effect for a period of five (5) years upon signature of both parties, unless earlier terminated by either party after having given notice of at least sixty (60) days, renewal is automatic.

This MEMORANDUM OF UNDERSTANDING shall be governed by the laws of Colombia with respect with the responsibilities of UDFJC, and the laws of the United Kingdom with respect with the responsibilities of LEMCO. If this memorandum of understanding has been translated into any languages other than Spanish, the original Spanish version as set forth herein shall prevail.
